1.Scope of Work

The Club is looking for contractors to provide onsite (i) high quality preventive maintenance, (ii) repairing services using trained manpower and (iii) supply of best quality genuine/compatible parts and material at cost-effective rates.

The Club is exploring AMC Non-Comprehensive Onsite Maintenance Contract (without spares). List of equipments are provided in Annexure-IV for maintenance purpose.

The Non-Comprehensive Onsite Maintenance Contract will include monthly preventive maintenance services, need-based repairing services (without spares), health check-up of equipment and cleaning.

The period of AMC will be for three years depending on the performance of the contractor.

2.General Terms and Conditions

Sealed quotations are invited for AMC of Physical Fitness Equipments functioning in Indore Residency Club, Indore for a period of 3 years.

Tender forms can be purchased from club's office or can be downloaded from the Club website www.indoreresidencyclub.org (the cost of tender form to be attached with the document as per the last date). Please refer Tender section on the Home Page of the Website. Please keep visiting our website for any corrigendum / amendments and submit the bid documents accordingly. Completed application should be accompanied by non-refundable Demand Draft for Rs. 590/- (i/c GST) drawn in favour of "Indore Residency Club, Indore" and EMD of Rs.10,000/- drawn in favour of "Indore Residency Club, Indore". Application without the prescribed fee will not be considered.

Tenders/Offers may be sent by hand or post to the Indore Residency Club, Indore, Residency Area, Radio Colony, Indore- 452 001. For any delay in post shall not be the responsibility of IRC. IRC, Indore accepts no responsibility for any loss/delay/non-receipt of offers not submitted in person within the stipulated time. Offers received late/incomplete are liable for rejection.

The technical bid will be opened at 7.00 hrs. on 23rd Oct 2021 in the presence of the authorized representatives of the Tenderers, who wish to be present.

The financial bids of only those Tenderers whose technical bids are recommended by competent committee / authority will be opened. The date & time of opening the financial bid will be as mentioned in NIT or shall be later, if there are more bidders, which will be intimated to the eligible Tenderers.

The offer of the Tenderer shall be valid for three months from the last date of submission of Tender/revised offer (if any). No Tenderer will be allowed to withdraw his tender after submission and during the bid validity period (three months). In case the tenderer does not honour his/her bid, the EMD submitted by the tendering firm would stand forfeited.

In deciding upon the selection of contractors for the work, great emphasis will be put on the ability and competency of bidder to provide high quality maintenance services using trained/qualified manpower and best quality parts and material at cost-effective rates (to be quoted for the entire duration, as per Annexure-V).

IRC Indore reserves the right to accept/reject any Tender in part or full, without assigning any reason whatsoever.

If the last date of receiving/opening of the Tenders coincides with a holiday of club, then the next working day shall be the receiving/opening date, the time shall remain as before.

Before filling the tender document, the bidder should inspect the physical fitness equipment installed at the Club to familiarize himself/herself with the various elements of services that are required to be rendered and to understand the quality levels of service that are required to be rendered. The costs of visiting shall be borne by the bidder. It shall be deemed that the contractor has undertaken a visit to the Club and is aware of the operational conditions prior to submission of the tender documents.

Tenderers are requested to furnish their bids in two parts namely (a) technical bid and (b) financial bid. The technical bid should contain the company profile, work experience, Income Tax PAN No., personnel employed, Earnest Money Deposit, Tax Identification Certificate, non- refundable tender submission cost, and any other relevant documents which the firm wishes to submit. The financial bid should contain the rate quoted in words and figures. Details of rate, taxes and discount, if any, may be quoted by the bidder. The sealed envelope of technical bid document should have superscription "Technical bid – Annual Maintenance Contract of Physical Fitness Equipment" and sealed envelope of financial bid document should have superscription "Financial bid - Annual Maintenance Contract of Physical Fitness Equipment". Put both these sealed envelopes in one envelope and send it to the Indore Residency Club, Indore, Residency Area, Radio Colony, Indore- 452 001 Phone: +91-731-2710190, should be submitted in the club office on all working days at 5.30 p.m. The last date of submitting the tender is by 5.30 pm 23rd Oct 2021. Incomplete bid document will not be accepted. Late submission will not be accepted. The tender will be opened on 23rd Oct 2021 at 7:00 pm by the competent committee / authority in the presence of tenderers or their authorized representative who desire to remain present at that time.

The intending tenderer will be required to deposit an account payee Demand Draft/Pay Order for Rs. 10,000/- as earnest money in favor of "Indore Residency Club, Indore". payable at Indore. The earnest money of the firms, whose quotations are not approved, will be returned after 07 days of award of contract to successful bidder.

In the event of breach of any terms and/or conditions of the contract, Indore Residency Club, Indore reserves the right to annul the contract and have the work completed alternatively at the contractor's risk and expenses without any further notice to him. The contractor will have no claim for compensation for any loss, which he suffers in case of default of the contracted terms. In case of any default by the contractor, his security deposit will be forfeited.

In case of any dispute, the decision of Indore Residency Club, Indore will be final and binding on both the parties. Further dispute, if any, will be settled in the court of law at Indore.

Financial bid of only those tenderers will be opened, who qualify technically.

The tenderer should sign and stamp with official seal on each page of the tender.

Bids which are late/vague/conditional/incomplete/not conforming to the laid down procedure in any respect will be rejected.

Tenders sent by telex/fax/telegram & e-mail will not be accepted.

The tender documents are neither transferable nor the cost of tender document is refundable under any circumstances.

The downloading of tender document from the website and/or submission of the same does not automatically qualify the tender.

Even after approval, if information/facts submitted by a tenderer are found misleading/incorrect/false etc., IRC, Indore reserves the right to disapprove an item/items for the current/future contract or may impose penalties as deemed fit. Non-compliance of any of the terms of tender and future instructions by IRC Indore will also warrant above penalties.

The rate quoted should be inclusive of onsite repairing (site situated at 7, Residency Area, Radio Colony, Indore-452001, M.P) and maintenance, all statutory levis, taxes and charges at the premises of IRC Indore.

The successful tenderer will have to deposit the performance guarantee in the form of FDR (3 Years + 45 days duration from date of LoA)/Demand Draft drawn in favour of **Indore Residency Club, Indore** at the rate of 10% of the total value of contract at the time of execution of contract, and the same will remain with the Club for 45 days beyond contract period for which no interest will be paid by IRC Indore.

In case of differences arising in the terms and conditions of the tender documents with the firm(s), the decision of IRC Indore shall prevail.

The successful tenderer who has been awarded the contract is required to make an agreement within 07 days from the date of award of this contract for AMC of Physical Fitness Equipment. The rates of successful tenderers will be valid for 36 months from the date of execution of this contract. Any increase of duration shall be considered on mutual consent with 5% increase in the 3rd years AMC rates.

IRC Indore reserves the right to modify/change/delete/add any further terms and conditions prior to actual signing of the agreement.

The English version of this tender shall only prevail in the matters of interpretation of any terms and conditions.

3. Eligibility Criteria

The intending bidder should have at least 02 (two) year of experience in providing annual maintenance contract services to reputed Companies / Institutions / PSUs / Central / State Government Organizations and having annual average turnover of Rs 10.00 lakhs (Rs. Ten Lakhs) during the last two financial years in similar services as per profit & loss account and balance sheet duly audited by the Chartered Accountant and the same should be attached as documentary proof.

The firm must have been registered on or before March 31, 2019 in the similar line of business.

Copy of last two financial year's Income Tax Returns.

Should possess necessary statutory licenses for their existing businesses.

4.Special Terms and Conditions

AMC for the physical fitness equipment would be non-comprehensive (without spares) onsite for a period of three years as decided by the Club. The non-comprehensive onsite contract will include repairing, preventive maintenance of equipment on monthly basis (thrice in 30 days) including cleaning, health checkup etc except for spares required to replace defective parts. It will be carried out and a report be given by an authorized personnel of the firm to the authorized personnel of Indore Residency Club, Indore. It also includes onsite need-based repairing. In such cases the complaints would be attended to preferably on the day these are reported or maximum within 3 working days. There will be no extra payment for attending need-based repairing.

The equipments are normally required to be repaired in the Indore Residency Club, Indore premises only. In exceptional cases when the equipment cannot be repaired in the premises and required to be taken out of campus, Indore Residency Club, Indore will not make any payment towards cartage and the expenses for the to and fro transportation of the equipment, it will be borne by the tenderer. Only genuine / compatible spare parts will be used by the contractor.

Payment will be released on quarterly basis i.e. 25% of the per year AMC charges after review of the work done in every three months, on production of invoice by the firm.

Penalty:

The penalty will be deducted from contractor's pending bills or through forfeiture of performance guarantee. The decision of the Club regarding penalty will be final and binding in deciding the nature of the default.

The Club through its officers, reserves the right of altering the specifications of works of adding to or omitting any items of work or of having portions of the same carried out in the Club by others and such alterations and variations shall not violate this contract.

The tender may be awarded to one or more tenderers in part or whole.

5.Arbitration and Dispute Resolution

Any dispute and/or difference arising out of or relating to this contract will be resolved through joint discussion of the authorized representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by Management Committee of the Club.

The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceedings shall be governed by Indian Arbitration and Conciliation Act 1996 as amended from time to time. The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the contractor shall continue to be made in terms of the contract. Arbitration proceedings will be held at Indore, Madhya Pradesh only.

6. Jurisdiction of Court

The courts at Indore, Madhya Pradesh shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
